- In two years, added 5 new distance / branch campus degrees, programs, and certificates to our offerings on the basis of cost benefit analysis, national and community research.
- Worked with academic colleges and departments to ensure the academic excellence of distance and branch campus courses and degrees by fine-tuning assessment tools.

- Re-connected the University with the Wind River Reservation's Eastern Shoshone and Northern Arapaho Tribal Nations, working with the President to create the first WRR-UW Educational Task Force, the first such body in about 20 years. The Task Force, which meets monthly, has recently begun work on 5 different areas of concern, including an American Indian Studies-based degree in Natural Resources for transfer from Central Wyoming Community College to the University of Wyoming.
- Broadened fundraising efforts, annual giving, and alumni contacts.
- Completed and opened a \$32 million building at University of Wyoming at Casper, shared between UW/C and Casper College.
- Renewed and maintained connections with the 7 Wyoming community colleges to ensure transfer-credit programs and development of curricula and degrees for our shared students.
- Together with the University Deans' Council, drafted the new University Academic Plan for 2015-2020.
- Worked to achieve university-wide transparency of reporting on the Outreach School's policies and budget.
- With the Vice President of Student Affairs, initiated the Outreach School-Student Affairs Enclave to involve both groups in discussion of recruiting a diverse student body, retaining students and persistence to graduation, enrollment management, student support, financial aid, early alert, and other student success initiatives and their assessment.
- Reorganized responsibilities of key staff members to reflect current needs in the Division of Outreach Credit Programs, the Outreach Deans' Office, and UW/Casper.
- Worked with University Legislative Liaisons on budgetary appropriations and distanceeducation legislation, including budgetary requests and State Authorization.
- Created Marketing Manager position to serve all Outreach School areas, as manager of a newly formed team of marketers organized by their Marketing Plan.
- Organized core of an Outreach School Engagement Council of Advisors.
- Successfully conducted the self-study and on-sight visit of Outreach Credit Programs Division by the Higher Learning Commission in 2013. Maintain strong communications with the HLC.
- Provided decisive financial and logistical support for major campus-wide initiatives, including the adoption of Canvas as the new LMS, the creation of an English Language Center for International Students, the founding of the Committee on the Women and People of Color; the UW Community College Transfer Initiative.
- Enabled a variety of international and statewide engagement initiatives to encourage faculty research and student experiential learning.

AS HEAD OF THE UNIVERSITY OF WYOMING ENGLISH DEPARTMENT, I worked collaboratively to accomplish the following:

- Started the M.F.A. program in Creative Writing that in 7 years became ranked 30th in the nation.
- Balanced the budget. Successfully argued for a Legislative Excellence Professorship that brings \$200,000 to the department annually. Secured a gift to our endowment that so far totals \$1,200,000.
- Increased tenure-track faculty by 26%, lecturers (who have job security and full benefits) by 30%, and staff by 25%.
- Negotiated Memoranda of Agreement to ensure courses and teaching staff for Latino/a Studies, American Indian Studies, African-American and Diaspora Studies, Gender and Women's Studies, and Religious Studies.
- Supported the creation of graduate certificates in American Indian Studies, African-

American and Diaspora Studies, Gender and Women's Studies.

- Underwrote the beginning of the "Synergy Program" for at-risk first-years, which won the TIAA-CREFF Hesburgh Award for Leadership Excellence (2007) and became the pilot for a campus-wide first-year success initiative.
- Created an English/English Education major working with the College of Education that reduced graduation time from 5 to 4 years while meeting National Accreditation Criteria.

- Engaged faculty in first round of curriculum assessment funded by internal grants. Began move to outcomes-based assessment.

- Encouraged faculty grant writing, research, and publication: in 3 years, from 18 researchers and creative writers, 14 books published; \$80,000 in grants.
- Created graduate student success program to increase on-time completion, including piloting a course on how to write the M.A. thesis.
- Created a distance M.A. in English program now in its second cohort.

- Organized the writing and passage in the Senate of Unireg 808, the Post-Tenure Review Policy; negotiated its acceptance by the Board of Trustees.

- Chaired weekly Executive Council meetings of the Faculty Senate and monthly meetings of the full Senate.

- Partnered with Student and Staff Senates on diversity, health care, and grading issues.

DIVERSITY RECORD

Domestic Diversity

- Non-traditional students: about 90% of Outreach students are non-traditional (ages 24+)
- Women: 70% of Outreach's distance learners are women
- **First generation students**: The majority of Outreach students are first-generation students.
- **Financially challenged**: 84% can only go to school part-time and many don't qualify for the state or federal support. Outreach initiated a micro-grant program to enable these students to persist.

- Chaired the International Education Steering Committee (IESC), composed of Deans, interested VPs, International Student and Studies Professionals from Student Affairs, Modern Languages, and faculty leaders in Global and Area Studies and the Global Institute.
- English Language Center: The IESC rustled up internal funding for and created the English Language Center for non-matriculated international students that opened in fall 2015, with expanding enrollments anticipated from fall 2016. The English Language Center was part of the Outreach School.
