Program Overview

The Fay W. Whitney School of Nursing offers a graduate program that prepares Psychiatric Mental Health Nurse Practitioners (PMHNP). PMHNPs are advanced practice registered nurses who provide a full range of psychiatric care, including assessing, diagnosing, and managing the prevention and treatment of psychiatric disorders and mental health problems. PMHNPs work in various settings, from outpatient settings such as clinics to hospitals.

This master's program, started in the fall of 2005, began with funding assistance from the Health Resources and Services Administration (HRSA). Student enrollment began in the 2005-2006 academic year.

The State of Wyoming established an educational loan repayment program for PMHNP students in 2006. Under this program, the University of Wyoming was authorized to provide up to \$10,000 per academic semester or \$2,500 per summer session for nurses enrolled in a PMHNP program full-time. Students enrolled part-time can receive funds proportionally reduced based on the number of credit hours the students is taking.

The PMHNP loan program was organized to support six students for their two years of education during the first year of the funding and then to add an additional six more for two years starting in the second year of state funding. Funding to continue the program for FY 2010-2011 at four students per year was contained in the standard budget for the UW 167 Medical Education state budget. Students receiving support from the State are obligated to actively engage in professional practice as a PMHNP for up to one year for each academic year of study for which support was provided under this program, or repay all amounts expended by the State for the student's education.

Required Reports

W.S. 21-17-116 (e) – Under this provision, like the WWAMI program, the University's Board of Trustees, upon the recommendation of the President of the University, may relieve a student from repayment of a loan provided under this section for undue hardship. The provision requires the University to report to the Joint Labor, Health and Social Services Interim Committee the number of students who have been relieved of the obligation to repay the loan.

W.S. 21-17-116 (f) – Under this provision, again similar to the WWAMI program, effective July 1, 2008, all loan repayments are to be credited to an account to be used by the University to fund loans under this program. This provision requires the University to report to the Committee regarding expenditures from this account during the preceding fiscal year.

Loan Repayment Update

The PMHNP loan repayment program supported eleven (11) students with FY2011 funding. Of those, nine are currently enrolled, one has repaid, and one is in the grace period.

A total of 30 students have been supported by the PMHNP loan payment program since it was established. The table below summarizes the current status of those students/graduates as of June 30, 2011. Nine graduates are currently in the process of repaying the loan through professional practice as a PMHNP in Wyoming (Deferment for Practice). One former student is in collection, four graduates are repaying the loan, and one graduate has repaid the loan. Four graduates have completed the repayment of the loan through practice in Wyoming. The UW Board of Trustees canceled the loan due to hardship for one former student.
