

# First Job Jitters:

# How to Nail the First Impression

#### START WITH WHY - UNDERSTAND THE ASSIGNMENT

This process can be dependent on your supervisor. They may offer clear, concise, simple directives or unclear, incomplete, or hurried expectations. Regardless, try not to leave their office without a standard set of questions answered. Carry a form or checklist with you each time you visit with them, so you can ask follow-up questions.

#### LEARN ABOUT YOUR NEW ASSIGNMENT

- Who is the client?
- What is the expected format of the assignment?
- Who is the final recipient of the assignment?
- When is the deadline?
- What is the billing/client number, if applicable?
- Do you need to code into the billing process/track time, etc.?
- How much time should the assignment take?
- How would the attorney prefer you to follow up?
- Should you spend additional time reading background files?



Then move forward in understanding the facts, performing a cost-benefit analysis, and focusing on complete research - all while continuing to communicate with your supervising attorney (early and often).

#### **Overstating Accomplishments**

If discovered, even the slightest overstatement of your credentials could cast serious doubts on your credibility.

#### **Seeming Arrogant**

Know how to draw the line between conveying confidence and appearing self-important.

Present your accomplishments and salary expectations in an assertive, confident manner if you're to receive the best possible offer.

# Laying Your Cards on the Table Too Soon

Delay discussing compensation for as long as possible. An employer becomes increasingly committed to hiring you.

# Ignoring Other Aspects of an Offer

Consider other elements of a job offer that may be equally valuable (i.e. bonus structure, floating holidays)

#### **Drawing a Line in the Sand**

Issuing an ultimatum is usually counterproductive and may cause negotiations to fall apart.
